Woodland Management Plan for Blaisdon Woods

The Clerk reported receipt that day of an e mail from John Evans, Forest Manager, Andrew Bronwin & Co Ltd inviting the Parish Council to comment on the draft Management for Blaisdon Woods. Comments were requested by 31 January 2018.

RESOLVED

That an extension of time be sought to enable the Parish Council to consider the draft plan at its next meeting on 14 February 2018.

Local Government Boundary Commission Electoral Review of the Forest of Dean

The Clerk report receipt of a letter dated 16 January 2018 from the Local Government Boundary Commission notifying of publication the Commission's report and its final recommendations for the Forest of Dean District area. A full copy of the report could be accessed on the Commission web site www.lgbce.org.uk and an interactive map of the final recommendations could be accessed by the link <https://consultation.lgbce.org.uk> . The final recommendations proposed that the Forest of Dean District Council's 38 councillors should represent 5 three-councillor wards, 7 two-councillor wards, and 9 one-councillor wards across the district. Blaisdon Parish would be in the Westbury-on-Severn Ward.

RESOLVED

That the information be noted.

Preparing for Year end and Audit 2018

The Clerk reminded members that new auditing arrangements would come into place on 1 April 2018 which would affect the Annual Governance and Accountability Return for year end 2018. The Gloucestershire association of Town and Parish Councils (of which the Parish Council was Member) would be running a training course on 6th February 2018 and the Clerk suggested that it would be beneficial to attend. The current financial provision for training in the 2017/18 budget was £50 although the course would cost £55.

RESOLVED

That the Clerk be authorised to attend the course as outlined and the Council hereby authorise the payment of £55.

That Historic England be informed that the Parish Council have no objections and support the proposal to List the structure.
