

**GLOUCESTERSHIRE COUNTY COUNCIL TEMPORARY TRAFFIC ORDER**  
**VARIOUS ROADS FOR Q1 AND Q2 (VARIOUS TOWNS AND PARISHES)**  
**FOREST OF DEAN DISTRICT ORDER 2022**

WHEREAS the Gloucestershire County Council ("the Council") being the Traffic Authority for the roads as detailed in the schedule below ("the Roads") is satisfied that use of the Roads should be prohibited and restricted because works are being or are proposed to be executed on or near it.

NOW THEREFORE the Council in exercise of its power under Sections 14, 15 and 16 of the Road Traffic Regulation Act, 1984, as amended, hereby makes the following Order:-

1. No person shall park nor wait or cause anyone to park nor wait along the Roads throughout the duration of the works;
2. Except for pedestrian access to properties, no person shall proceed nor cause or permit any vehicle to proceed along the Roads;
3. Nothing in Article 2 shall render it unlawful for a vehicle being used for Police, Fire Brigade or Ambulance purposes to proceed along the Roads;
4. Nothing in Article 2 shall render it unlawful for a vehicle being used by a statutory undertaker responding to an emergency situation to proceed along the Roads;
5. The Roads fall in Various Towns and Parishes as described in the schedule below in the Forest of Dean District and in the County of Gloucestershire;
6. This Order shall come into operation on the 1<sup>st</sup> day of April Two Thousand and Twenty Two and shall continue in force for a period not exceeding eighteen months;
7. This Order may be cited as "Gloucestershire County Council Temporary Traffic Order Various Roads for Q1 and Q2 (Various Towns and Parishes) Forest of Dean District Order 2022".
8. In the event of any inconsistency or ambiguity between the content of this Temporary Order and any existing permanent/experimental Order(s) imposing restriction(s) on the Road or diversion routes the latter will be suspended for the duration of the works and the provisions of this Temporary Order shall prevail during that period.
